MAINS

Essay

To be written in the medium or language of the candidate's choice. Candidate is required to write an essay on specific topic or topics. The choice of subjects will be given. They are expected to keep their thoughts closely to the subject and arrange their ideas in orderly fashion and be concise. Credit will be given to effective and coherent expression.

General Studies Paper IV

This paper will include questions to test the candidates' attitude and approach to issues relating to integrity, probity in public life and his problem-solving approach to various issues and conflicts faced by him in dealing with society. Questions may utilise the case study approach to determine these aspects. The following broad areas will be covered:

- **Ethics and Human Interface: Essence, determinants and consequences of Ethics in-human actions; dimensions of ethics; ethics - in private and public relationships. Human Values - lessons from the lives and teachings of great leaders, reformers and administrators; role of family society and educational institutions in inculcating values.**
- **Attitude: content, structure, function; its influence and relation with thought and behaviour;**
- **moral and political attitudes; social influence and persuasion.**
- **Aptitude and foundational values for Civil Service, integrity, impartiality and non-partisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker-sections.**
- **Emotional intelligence-concepts, and their utilities and application in administration and governance.**
- **Contributions of moral thinkers and philosophers from India and world.**
- **Public/Civil service values and Ethics in Public administration: Status and problems; ethical concerns and dilemmas in government and private institutions; laws, rules, regulations and conscience as sources of ethical guidance; accountability and ethical governance; strengthening of ethical and moral values**

in governance; ethical issues in international relations and funding; corporate governance.

Optional Syllabus
